RENTAL AGREEMENT

Please review the following terms and agreements pertaining to your Limousine Rental:

Rental of limousines and or other vehicles from YUMA SKY LIMOS is subject to the following terms and conditions:

All reservations require a major credit card for possible incidentals. Reservations are finalized upon receipt of a signed contract/agreement.

There is a 3 hour minimum during the evenings on Fridays, Saturdays and Holidays.

There is a 2 hour minimum for daytime and weekday events.

There is a 50% deposit required on all bookings to reserve your date and time. There is a 7-day cancellation policy, if cancelled, deposit is non-refundable.

Limousine cannot be loaded beyond seating capacity.

Balance is due at time of service.

Tip/Gratuity is included in total.

The following are strictly prohibited and any violation thereof is subject to immediate termination of our services.

- Smoking tobacco or any other substance is prohibited inside our vehicles;
- You may bring your own alcohol as long as all guests are of legal age to consume (21 years or older);
- Consuming any type of illegal drug is prohibited;
- Hanging any portion of body out the windows is prohibited

No possession, sale or consumption of any type of narcotics or illegal drugs is permitted. Violations will result in immediate termination of contract and services and forfeiture of all paid deposits and fees for service. Client and renter are responsible for his/her guests, for any damage to the interior and equipment's of the vehicle. This is including but not limited to: gum, wine and alcohol spillage, vomiting, breakage of champagne, wine and drink glasses, breakage of decanters, breakage of lights, television, radio, CD player. Repair and replacement of items shall have a minimum charge of at least \$250. If anyone gets sick in the car there is a \$500 clean up charge. All passengers agree to behave in an orderly and well-behaved manner. YUMA SKY LIMOS reserves the right to expel any person from the vehicle and/or terminate this contract in the event of a violation of any of these conditions by any passenger. In the event of such early termination, no portion of the rental fees shall be refunded. Driver also has the right to terminate the service without refund; if there is a blatant indiscretion on the part of the client or any disagreement among the parties.

We do not take any responsibility for items that are left in the vehicle during or after completion of the limousine rental period.

YUMA SKY LIMOS shall not be held responsible for late arrival caused by (but not limited to) acts of nature, traffic delays, breakdown, incorrect pickup and drop-off information, and any situation beyond our control. In the event any part of this contract is declared unenforceable, the remaining provisions of this agreement shall remain in full force and effect.

This agreement must be signed by either a parent or legal guardian over the age of (18)

MINOR AGREEMENT

Dear Parent of Guardian, the below policies are specifically designed to help ensure you Teenagers' night is both safe and enjoyable. Our policy regarding drugs and alcohol complies with the applicable laws in the State of Arizona. We appreciate you in assisting us in reviewing the following regulations with your son/daughter.

1. All pickup and drop off locations must be predetermined and/or approved by the parent or guardian executing this agreement. Your chauffeur will be instructed to obtain permission of a parent or legal guardian in the event of any changes to the itinerary. A contact phone number must be provided to your chauffeur on or prior to the date of service in the event of any questions.
2. At all times the privacy divider in the limo will be locked open.
3. The following are strictly prohibited and any violation thereof is subject to immediate termination of our service:
 - Smoking tobacco or any other substance is prohibited inside our vehicles;
 - Drinking alcoholic beverages of any type inside our vehicles are prohibited;
 - Carrying and or storing alcoholic beverages of any type inside our vehicles are prohibited;
 - Consuming any type if illegal drug is prohibited;
 - Having intimate relations in our vehicles is prohibited;
 - Hanging any portion of body out the windows is prohibited;
 - Vandalizing, damaging, staining, breaking any part of the vehicle, including the interior, exterior as well as glasses and other items in or on the vehicle are prohibited and subject to additional charges for repair/replacement of damages. If anything is broken there is a \$250 minimum charge. If anyone gets sick in the car there is a \$500 clean up charge.

Note: In the event of any violations of the above regulations, our chauffeur will immediately terminate his service and all passengers will be dropped off at the initial pickup point. In the event of any cancellations of the rental, the total contract price will be charged. No refunds are given and all deposits are non-refundable.
